It was **resolved** to accept apologies from Cllr Copsey and Cllr A Youngs.

### 139/23 To receive Declarations of Interest on Agenda Items and Dispensation requests

Cllr A Osler and Cllr J Osler declared an interest on planning application 23/01693/F and did not take part in the discussion or resolution of this time. The Clerk distributed the dispensation request forms for Councillors to complete if necessary.

## 140/23 To confirm as a correct record the Minutes of the Ordinary Meeting of the Parish Council held on 13th September 2023

It was **resolved** to approved the minutes as a true an accurate record of the meeting and they were duly signed by the Vice Chair.

Cllr Welch asked if the 'undertaking' form was signed and forwarded to the solicitor in relation to the Orchard Way lighting. The Clerk confirmed that it had been sent to the solicitor.

#### 141/23 Matters Arising (Clerks Report)

The Clerk reported that planning decisions would be reported later in the meeting and there were no other reports to give.

#### 142/23 To receive an update from County or Borough Councillors

Cllr Stoney reported:

That crucial crew event for year 6 children is happening again this year. They will have a chance to take part.

Healthy eating scheme now happening.

Looking to recruit more volunteer drivers for local schemes.

Support for getting into employment scheme is being offered.

County deal is still being considered, the public will have the opportunity to elect the leader to head this. Still up to the people to decide if this goes ahead, and Cllr Storey will keep the Parish Council up to date on the progress of this.

QE new hospital is being developed currently and will be finished by 2030. Planning matters are still a contentious issue in Parish councils, there is a new chair for this committee. All meetings are live on Youtube every Monday for people to view.

New leader is doing a good job at county too.

#### Public participation

Member of the public was invited to speak as they had just arrived 7.13pm discussed speeding in the village. And what they had observed in the village. Councillors discussed the speed limit signs. Would like a 30mph speed limit sign on Feltwell Road. It is both cars and lorries that are speeding. Parishioner feels there is no speed signs or school sign near the school. It was acknowledged that the traffic in the village is getting far worse in terms of the volume of traffic. The are 20mph signs are for lorries. It was felt that more 20mph signs are needed in the village to remind drivers. Cllr Storey discussed this issue and noted that lorries have been an issue for along time and lorries are now getting much larger. Advised that if registration numbers could be gained then the company can be rung up to report the issue. Ask highways to come out and study this issue to see if they can help. The school would like to get involved and perhaps the Zig Zags could be increased. At the T junction on Feltwell Road is a problem. It was agreed that there needs to be a visit from A Wallace at highways. Cllr Storey suggested that individuals write into highways to express their concerns.

### 143/23 To Note Any Councillors Concerns or items for next meeting and note forward work programme.

Cllr Whitehead - Playing field - Toilet behind hut needs clearing, goal post needs put into a good position or removed to make area tidier. Play area of grass not cut again. Bin is full, Clerk to ask handy man to clear bin.

Clerk to ask bowls club to not drive the full distance to the entrance of the club, they need to keep to the car park.

Garage is in poor repair and perhaps needs to be repaired or replaced. Clerk to ask handyman and Mr Pink to consider making repairs.

New exist on Campsey Road onto the junction a property has created a new exit from their property - Clerk confirmed this has already been reported this. Clerk received phone call concerns about this during the month. Clerk needs to follow up because no response yet from planning enforcement.

Cllr Smith - over grown path going out onto the A10 - Clerk to report.

Cllr Edwards - play area has not been cut and cemetery not weed killed, Clerk to follow up with CGM.

Cllr A Osler - Highway Rangers need to clean the white gates on their next visit.

It was **resolved** that as they have been there many years they should be allowed to remain in place. However, they should be cut to the level to the headstones and kept trimmed around the edges.
