Trod/Bridge - Parish Partnership money

Highways suggested that as there are difficulties in agreeing the scheme with IDB, the Parish Council's contribution should be returned. This will ensure the accounting records will be concise. Highways can work with the Parish Council again to process and re submit the estimate once agreements are made between stakeholders.

The Councillors discussed this matter and would like the bridge to be put in place at the site. It was **resolved** this would be an agenda item for the next meeting. Money would not be requested to be returned at this time.
